Keeping our position of not endorsing any candidate we sent out letters to both candidates asking for responses to the following questions. Following each question in bold is the candidate's response.

As you are a candidate for public office, we are looking for a written statement of your position on the following questions:

1. Which version of the Municipal Health Insurance Law passed on July 11, 2011 – the original House version or the Senate version – would you have voted to support as a first choice? (To refresh your memory the House version stripped out collective bargaining rights and left retirees unprotected and the Senate version kept some collective bargaining rights, protected retirees and included them in future decision making.)

Roger Brunelle response: The Senate version.

Keiko Orrall response: I would have voted to support the original House version.

2. What is your position on maintaining ("grandfathering") retiree health insurance benefits to the premium percentage contribution rate they had when they retired (similar to the State system regarding retiree health insurance)?

Roger Brunelle response: I would want to maintain the percentage at the time of retirement.

Keiko Orrall response: I would favor grandfathering health insurance benefits however if we enter a situation financially as in the case of Central Falls, RI which went bankrupt we would need to revisit health insurance benefits.

3. If you were given the opportunity today, would you vote to increase the COLA base for all retirees (Plymouth County and Massachusetts Teachers Retirement systems) from the current \$12,000?

Roger Brunelle response: Yes

Keiko Orrall response: While it would be nice to increase the COLA base for all retirees from the current \$12,000, we do not have the money to do so unless other areas of state, county, and municipal government are adjusted. Given the difficulty the county and municipal budgets are having these days, it seems unlikely that funds will be available at those levels of government to afford an increase. Therefore my plan is to look for ways to cut state spending to increase local aid to relieve county and municipal budget constraints.

NOTE ON FLU SHOT COVERAGE

Gene Turney has been in touch with BC/BS and learned the information cited below.

BC/BS has advised they will cover Flu Shorts with no co-pay as follows:

Primary Doctors Office if visit is for Flu Shot only. If Flu Shot is given in conjunction with an office visit then co-pay will apply.

CVS Minute Clinic only. Will not pay for Flu Shot at a CVS Pharmacy. Locations of CVS Minute Clinics can be found at WWW.CVS.COM

Mollen Immunization Clinics. Locations can be found at WWW.FLUSHOTSUSA.COM. It appears that all the Mollen Clinics are held frequently at various area Wal-Mart locations.

LEGAL ISSUES UPDATE

The joint hearing for the MTA and MRIG legal cases is now scheduled for 2:00 PM, November 7, 2011 at the Brockton Superior Court House, 72 Belmont Street, Brockton, Court Room 5. We will send out an email closer to the date for those who want to attend and carpool.

NEW MEDICARE ENROLLMENT NOW STATE LAW

Pending finalization of the new health care regulations regarding implementation of the new law, we are advising our membership that if anyone is currently planning to enroll in Medicare Part B, they may want to hold off as the new legislation contains language that says the Town shall pay any penalties incurred for late enrollment into Medicare Part B. This could save the retiree those penalties.

The new Health Care Reform act also states that the Town shall set up a PEC (Public Employee Committee) of which one member shall be a representative of the retirees and named by the Retired State, County and Municipal Employees Assoc. of Mass. The Executive Committee will submit

names to Mass. Retirees requesting appointment to this Committee as required by law. Gene Turney has worked with Bill Rehrey of Mass Retirees on several of our issues and we would expect his cooperation.

The Town will save considerable money when retirees are forced one Medicare Part B. We hope to work with the Town on passing on some of those savings back to the retirees to help defray the cost of the Medicare Part B monthly premiums.

BEACON HILL AND PENSION REFORM

The Senate will be discussing "Pension Modernization" this week in Boston. The following is taken from a message MTA President Paul Toner and Vice President Tim Sullivan sent to their membership:

The Massachusetts Senate is scheduled to vote on a pension "modernization" bill on Thursday, Sept. 15, that would substantially reduce pension benefits for future preK-12 and public higher education members, as well as other public employees. *The Senate bill contains a provision that would only increase the COLA base to \$13,000! That translates into a \$2.50 increase per month!* The MTA is strongly opposed to this bill.
