# MEDICARE SIGN-UP WITH SOCIAL SECURITY

The Town Treasurer has been sending out letters to various groups of retirees advising them to provide them with information and to sign up for Medicare Part B at a Social Security Office. If you did not get a letter and think you should have, you should contact the Town Treasurer's Office and follow-up to make sure your insurance will continue past July 1<sup>st</sup>. The dates referenced for sign up for Medicare must be followed (1/1/12/ to 3/31/12) to avoid penalties for late enrollment.

The Town Treasurer's Office will have an open enrollment period in May/June to choose what additional supplement plan you will want to participate in.

The telephone number for the Taunton Social Security Office is 1-877-505-4546. You will be greeted by a recorded menu of options, we found that if you hit "0" at the end of each menu you will speak to a "real" person in the Taunton office who will assist you. If you are not in the local area any Social Security Office can assist you. The Taunton Office is located on Dean Street (Route 44) for those who want to go directly there. As a reminder, make sure you photocopy anything you sent to Social Security.

We have sent a letter to the Board of Selectmen asking that they provide a letter stating the Town's method of paying all penalties assessed to retirees for late sign-up for Medicare. If we receive such confirmation from them we will forward to our membership to retain in your files.

## **INCREASE IN COLA BASE**

The Plymouth County Retirement Board has voted an increase to the COLA base from \$12,000 to \$13,000. This base will be effective July 1, 2012 and was approved by a narrow vote of the Treasurers of the Retirements System's units (23 towns and 29 other units, such as housing authorities and school district workers).

This will be an increase of \$30.00 per year or **\$0.57 per week maximum** for our retirees.

In a weighted vote (Middleborough has 8% of the vote) the **Town of Middleborough** representative, Judy MacDonald, **voted against this increase**. Bill Farmer, Executive Director of the Retirement Board, verified this information.

#### **MRIG ANNUAL MEETING**

MRIG's Annual Meeting will be held on May 15, 2012 at the Middleborough Council on Aging, 558 Plymouth Street at 1:30 PM.

The speaker will be the Regional Director for SHINE Program Serving Health Information Needs of Elders. With the change to Medicare and having to pick new supplement plans the Executive Committee thought there would be lots of interest in this.

#### **WEBSITE**

Charlie Armanetti has been working on developing a website for MRIG and we expect it will be ready to roll out just before the Annual Meeting. We will provide you information prior to the meeting on how to access the website and hope you will bring questions and comments to the meeting on your reaction to the website.
