ANNUAL MEETING TOPICS PLYMOUTH COUNTY RETIREES COLA

Mr. Dennis Gallagher, Office Coordinator / Contract Specialist of Plymouth County Retirement will be attending our Annual Meeting. He will be announcing that the Plymouth County

Retirement System Board has voted to increase the COLA base to \$14,000.00, and to authorize a 3% COLA starting 7/1/16. This is good news for our retirees. Mr. Gallagher will also talk about new services for Plymouth County retirees and take any questions.

TEACHERS COLA

Right now Gov. Baker has included a 3% COLA in his proposed budget for the upcoming year, but it is still using the \$13,000.00 base. We hope that this will not be cut in further budget negotiations.

HEALTH CARE CHANGES

Nola Jean Goodrich of the Town Treasurer's Office will be at our Annual Meeting. She is the retiree contact person regarding health care and retirement issues.

At the Annual Town Meeting in 2013 there was an article to disburse Mitigation Funds to Medicare retirees over a period of time. We have spoken with Judy MacDonald, Town Treasurer and agreed to a reduction in premium of \$2.59 per month starting 7/1/16 to disburse the remaining funds not used during the last reduction period. This reduction will run for one year and will return all the agreed mitigation funds to the retirees. More on this at the Annual Meeting.

Medicare retirees again faced a change this January in our prescription drug plan – Silverscript was introduced as the new provider. Generally we have not heard many complaints, some are paying more than they used to, some are paying less, and some have found more paperwork to get some prescriptions covered. How are you finding the new program? Let us know, we were promised there would be little change, let's see if this is so.

WEP REFORM, NEW VETERANS BENEFIT, AND IMPROVEMENT IN AFTER RETIREMENT EARNING LIMITS

For anyone who has worked for both the public sector and the private under Social Security you know about the Windfall Elimination Provision that offsets some of your Social Security earnings. As an update, hearings are being held in Washington on this. A bi-partisan group of congressmen on the Ways and Means Committee (Congressman Richard Neal, D-MA, Kevin Brady, R-TX, Sam Johnson, R-TX) have introduced HR711 to address changing the WEP provisions. The Mass. Retirees have been taking a very active role in fighting for the improvement titles above. You can follow these stories on the Mass. Retirees website and we will explain them at our Annual Meeting.
