HEALTH INSURANCE UPDATE

The Town has recently contracted with the consulting group, NFP, to research the possibility of leaving the GIC program that currently provides health insurance to the Town. The Insurance Advisory Committee (IAC) voted to agree with this process.

NFP has been paid \$9,500 to research on the Town's behalf information on competing health insurance groups and to advise the Town as to what is the most advantageous route for the Town to follow in providing health insurance to employees and retirees. They are to return this information within a 2-3 month period. Town Manger Nunes is to share this information with the IAC when he gets it. If the Town should decide to leave GIC the State has to be notified by 12/1/18 to leave the program effective 7/1/19.

We are following this process and reaching out to other towns who have left GIC and what has been their experience. At the end of this article is a short survey we would like to have you respond to regarding your feelings about the GIC health insurance/prescription benefit program.

For those members who receive this newsletter by email you will receive a second e-mail from us with a survey questionnaire that you can answer on line.

The State's Group Insurance Commission voted in February to eliminate several health care plans offered to active employees and retirees. After a huge unfavorable response from all sectors, unions, teachers, retirees, State Senators and Representatives and the Governor, the Commission reversed its vote and reinstated all of the health plans for this coming year.

This is only for the next year and the GIC Commission has stated that there will be more study about cutting back the plan offerings and scheduling more time for public input.

We are following both of the above issues and expect to have more complete information for you at the Annual Meeting in May. Coverage under either one of these options would only be implemented in July of 2019.

NEW RATES FOR 7/1/18 - 6/30/19

Medicare enrollees, insured under the UniCare Optional Medicare Extension (OME) plan, will see their monthly premiums drop by .3%. Medicare retirees enrolled in Harvard Pilgrim's Enhanced plan will see a 9.6% reduction, with Tufts Complement -5.4% and Health New England coming in at -2%. While Tufts Medicare Preferred registers a 10.3% increase in cost, it remains the GIC's lowest cost Medicare plan.

On the non-Medicare side (retirees and active employees), UniCare Basic Indemnity rates increase by 1.9% for individual coverage and decreases 3.6% for families.

TEACHERS COLA

Right now Gov. Baker's budget has not been published so the teacher's COLA is still in question, we expect that he will be including it in his budget and will keep you posted as we find out more news.

PLYMOUTH COUNTY RETIREES COLA

The Plymouth County Retirement Association Board has consulted with an actuary in regard to raising the COLA base to \$16,000. This would certainly be welcome news and again we will update the membership as we find out any information.

SOCIAL SECURITY INFORMATION

Starting in April of this year and continuing to April of 2019 the Social Security Administration will be sending out new Medicare cards that do not have your social security number on them. They will give you a new number that will be used only for Medicare coverage. This is a great improvement, I hope they come on a better grade of paper! These cards are free and the only thing you have to do is make sure your mailing address is up to date. Call 1-800-772-1213 if you need to update your mailing address.

We have also been warned that "scammers" posing as Medicare agents or health care providers are calling people and telling them that they need to buy a replacement card, this is <u>not</u> true.
